

RECORD OF PROCEEDINGS

Public Hearing

Held July 24, 2023

The public hearing of the Saybrook Township Board of Trustees, to adoption of digital zoning map & redraft of non-conformities primarily permitting rebuilds, was called to order at 7:00 pm by Chairperson Robert Brobst along with Trustee Thomas Pope and Fiscal Officer Larry Johnson. Saybrook Township Zoning Commission on June 16, 2023, adopted a resolution recommending approval of the Zoning of digital zoning map & redraft of non-conformities primarily permitting rebuilds of destroyed structures.




